HMH Advisory is a well-established accounting firm with over 50 years of experience, employing 54 staff across business services, financial planning, and IT. With nine partners and 245 SMSF clients, the firm operates nationally from its base in Mont Albert, in Melbourne's eastern suburbs.

Adapting to legislative change

Changes to SMSF legislation mandated the separation of audit and accounting functions. At HMH, these had previously operated in close proximity—even on separate floors within the same building. The changes triggered a major operational shift and a significant loss of audit revenue.

When Carly resigned amid the transition, HMH began evaluating options for replacing its in-house audit capability. Cost was a key factor, especially with the decrease in audit revenue. The challenge was to maintain the firm's high standards and integrity while finding a more sustainable auditing solution.
